Project Lemonade

Last week, Shayla Sparks, Brian Phillips and Koehn attended the grant administration workshop in Jefferson City for Project Lemonade. We have

been told that we have the grant and it has been loaded into the system. The State is waiting on the National Park Service to send the award letters to them. Once they receive the letters from NPS, they can officially award the grant recipients. Koehn will be gathering our donors for a meeting soon to put a plan in place to start the project.

Hilltop Trailer Court

Abatement for Hilltop trailer court Koehn received notice from a potential buyer that negotiations are in place for the purchase of the property. Koehn will continue to work with the individual on the matter.
